PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68357 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Dennis Johnson of Route 1, Box 111-J, Cornelius, Oregon 97113, phone 647-2494, for the use of the waters of East Fork Dairy Creek, a tributary of Tualatin River,

for the PURPOSE of irrigation of 10.25 acres

that the PRIORITY OF THE RIGHT dates from

December 16, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.13**

0.13 cubic foot

The POINT OF DIVERSION is to be LOCATED: Diversion 1 - 50 feet South and 1000 feet West from the Center corner of Section 22; Diversion 2 - 50 feet South and 1300 feet West from the Center corner of Section 22; both being within the NE 1/4 SW 1/4 of Section 22, Township 2 North, Range 3 West, WM, in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 2 North, Range 3 West, WM Section 22 SE 1/4 NW 1/4 2.86 acres

SW 1/4 NW 1/4 1.54 acres

NW 1/4 SW 1/4 2.75 acres

NE 1/4 SW 1/4 3.10 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further water shall not be appropriated during the period from July 31 through September 15 of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before April 17, 1987 reasonable diligence and be completed on or before October 1, 19 87.

Complete application of the water to the proposed use shall be made on or before October 1, 19 88.
