## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68364** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Darrell T. and/or Janice H. Gath** of **574 Lomas Road, Jacksonville, Oregon 97530**, phone **899-8197**, for the use of the waters of a spring, a tributary of an unnamed creek, for the PURPOSE of **irrigation of 3.2 acres and supplemental irrigation of 6.8 acres**

that the PRIORITY OF THE RIGHT dates from **May 29, 1985**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.125 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **595 feet South and 925 feet West from the East 1/4 corner of Section 5, being within the NE 1/4 SE 1/4 of Section 5, Township 39 South, Range 3 West, WM, in the County of Jackson.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 39 South, Range 3 West, WM Section 4 NW 1/4 SW 1/4 6.8 acres**  
**Supplemental irrigation**  
**3.2 acres**  
**Primary irrigation**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **April 17, 1987**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **87**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **88**.
