PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68492** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Jacqueline L. Hall**, of General Delivery, Fields, Oregon, 97710, phone **495-2287**, for the use of the waters of an unnamed creek,

for the PURPOSE of **irrigation of 4.0 acres and supplemental irrigation of 10.6 acres**

that the PRIORITY OF THE RIGHT dates from **August 21, 1985 for 0.10 cubic foot per second and January 24, 1986 for 0.08 cubic foot per second**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.18 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **635 feet North and 1525 feet West from the Southeast corner of Section 8, being within the SW 1/4 SE 1/4 of Section 8, Township 41 South, Range 35 East, WM, in the County of Harney.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 41 South, Range 35 East, WM Section 8 SW 1/4 SE 1/4	0.6 acre Supplemental
SE 1/4 SE 1/4	10.0 acres Supplemental
SE 1/4 SE 1/4	4.0 acres Primary

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **April 17, 1987**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1987**.

Complete application of the water to the proposed use shall be made on or before **October 1, 1988**.
