## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68494** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Gordon Everett Myrah, PO Box 1199, Brookings, Oregon, 97415, phone 469-3411,** for the use of the waters of **unnamed creek, a tributary of Winchuck River,** for the PURPOSE of **domestic for one family and irrigation of 3.0 acres being 0.005 cubic foot per second for domestic and 0.02 cfs for irrigation**

that the PRIORITY OF THE RIGHT dates from **August 22, 1985**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.025 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **100 feet South and 200 feet West from the Northeast corner of Government Lot #2 (NW 1/4 NE 1/4), being within Lot #2 (NW 1/4 NE 1/4) of Section 6, Township 41 South, Range 12 West, WM, in the County of Curry.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 41 South, Range 12 West, WM Section 6 SW 1/4 NE 1/4 Domestic and 2.2 acres irrigation**  
**Lot #2 (NW 1/4 NE 1/4) 0.8 acres irrigation**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **April 17, 1987**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **87**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **88**.
