## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 65245 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Philip Murphy of Box 114, Monument, Oregon, 97864, phone 934-2421, for the use of the waters of Dry Creek, an unnamed draw and North Fork John Day River, and use of 9.2 acre feet stored water from a reservoir to be\* for the PURPOSE of irrigation and supplemental irrigation of 346.0 acres, being 0.23 cubic foot per second from Dry Creek supplemented by water from an unnamed draw, North Fork John Day River, and reservoir for irrigation of 9.0 acres; 1.13 cfs from\*\* that the PRIORITY OF THE RIGHT dates from June 30, 1983 for 1.36 cfs from Dry Creek for primary and supplemental irrigation and use of water from the unnamed draw, North Fork John Day River and Reservoir for supplemental irrigation; March 27, 1986 for 2.33 cfs from North Fork John Day River for primary irrigation,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 3.69 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: North Fork John Day River - 1720 feet South and 1500 feet West from Center of Section 1, being within the SW 1/4 SW 1/4 from Section 1; Outlet of Reservoir 2 - 4980 feet North and 800 feet West from Southeast Corner of Section 11, being within the NE 1/4 NE 1/4 of Section 11; Dry Creek - 3200 feet North and 150 feet West from Southeast Corner of Section 11, being within the\*\*\*

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

constructed under Application R-65249, Permit R-10604, a tributary of John Day River,

Dry Creek and reservoir for supplemental irrigation of 45.2 acres; 2.33 cfs from North Fork John Day River supplemented by water from the reservoir for irrigation of 93.3 acres; and use of water from the reservoir for supplemental irrigation of 198.5 acres, and use of stored water only from the reservoir for supplemental irrigation of 198.5 acres.

SE 1/4 NE 1/4 of Section 11; 5050 feet North and 400 feet West from Southeast Corner of Section 11, being within the NE 1/4 NE 1/4 of Section 11; 5800 feet North and 50 feet West from Southeast Corner of Section 11, being within the SE 1/4 SE 1/4 of Section 2, all in Township 9 South, Range 27 East, WM, in the County of Grant.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior rights existing for the same lands and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before May 9, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
