This permit is issued to City of The Dalles of 313 Court Street, The Dalles, Oregon, 97058, phone 296-5481, for the use of the waters of the Columbia River, a tributary of Pacific Ocean, for the PURPOSE of municipal

that the PRIORITY OF THE RIGHT dates from January 13, 1986

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 40.0 cubic feet per second

The POINT OF DIVERSION is to be LOCATED: 4000 feet North and 200 feet West from the Southwest corner of Section 2, being within the SE 1/4 NE 1/4 Section 32, Township 1 North, Range 13 East, WM, in the County of Wasco.
