PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68647 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to G. Allan and Helen G. Seward of 9255 NE Powell Hill Road, Dundee, Oregon, 97115, phone 538-8749, for the use of the waters of Hess Creek, a tributary of Willamette River, for the PURPOSE of irrigation of 56.49 acres

that the PRIORITY OF THE RIGHT dates from January 10, 1986

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.7 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: 1775 feet South and 1290 feet West from the Northeast corner of Section 28, being within the SE 1/4 NE 1/4 Section 28, Township 3 South, Range 3 West, WM, in the County of Yamhill.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:
 Township 3 South, Range 3 West, WM Section 27 SW 1/4 NW 1/4 20.35 acres
 Section 28 SW 1/4 NE 1/4 0.8 acres
 SE 1/4 NE 1/4 35.34 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before June 30, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89.
