## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68730 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Dawson Creek Park, Inc. of PO Box 2007, Salem, Oregon, 97308, phone 585-0020, for the use of the waters of two drainageways and seven (7) reservoirs, a tributary of Dawson Creek, to be constructed under Application \* for the PURPOSE of irrigation of 323.0 acres and aesthetics, being use of 703.0 gallons per minute from east drainage and 232.0 GPM from west drainage supplemented by stored water from Reservoirs 5 and 7 for irrigation and use of 66.0 GPM from east \*\* that the PRIORITY OF THE RIGHT dates from May 21, 1986 for 1000 gallons per minute and June 5, 1986, for 20 gpm

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1020.0 gallons per minute

The POINT OF DIVERSION is to be LOCATED: Reservoir 1- 2696.3 feet North and 229.6 feet East of Northwest Corner DLC #45; Reservoir 2- 2488.3 feet North and 245.6 feet East of Northwest Corner DLC #45; Reservoir 3- 2293.3 feet North and 156.6 feet East of Northwest Corner DLC #45; Reservoir 4- 1750.3 feet North and 51.4 feet East of Northwest Corner DLC #45; Reservoir 5- 1218.3 feet North and 152.9 feet West of \*\*\*

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

\* R-68729, Permit R-10624, for irrigation and aesthetics,

\*\* drainage and 19.0 GPM from west drainage for maintaining the seven (7) reservoirs for aesthetic purposes

\*\*\* Northwest Corner DLC #45; Reservoir 6- 1833.3 feet North and 791.4 feet West of Northwest Corner DLC #45; 1201.3 feet North and 502.9 feet West of Northwest Corner DLC #45 all in Section 28, being within the NE 1/4 NE 1/4; SW 1/4 NE 1/4; SE 1/4 NE 1/4 and NE 1/4 SE 1/4 all of Section 28, Township 1 North, Range 2 West, WM, in the County of Washington.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet from direct flow and storage from reservoirs to be constructed under Permit R-10624 provided further water shall not be appropriated during the period from July 31 through September 15 of each year, except for water legally stored, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before July 17, 1987 reasonable diligence and be completed on or before October 1, 19 88 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
