PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68474 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Fred Bussmann of Route 1, Box 1371, Bandon, Oregon, 97411, phone 347–4208, for the use of the waters of Four Mile Creek, a tributary of Pacific Ocean,

for the PURPOSE of irrigation of 70.0 acres

that the PRIORITY OF THE RIGHT dates from January 6, 1986

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.875 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: 1430 feet South and 2440 feet East from the Interior quarter corner of Section 2, being within the SE 1/4 SE 1/4 Section 2, Township 30 South, Range 15 West, WM, in the County of Coos.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 30 South, Range 15 West,WM Section 2 SW 1/4 NE 1/4 8.0 acres SE 1/4 NE 1/4 2.0 acres NE 1/4 SE 1/4 29.0 acres NW 1/4 SE 1/4 30.0 acres SE 1/4 SE 1/4 1.0 acre

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before August 7, 1987 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1988 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
