PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68666 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Peter Gleysteen of 1241 Bernal Avenue, Burlingame, California, 94010, phone (415) 347-8643, for the use of the waters of Applegate River a tributary of Rogue River, to be supplemented by appropriation from Applegate Lake * for the PURPOSE of irrigation of 5.0 acres

that the PRIORITY OF THE RIGHT dates from January 30, 1986

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.06 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: 70 feet North and 250 feet West from the South quarter corner of Section 5, being within the SE 1/4 SW 1/4 Section 5, Township 37 South, Range 6 West, WM, in the County of Josephine.

* Reservoir constructed under Application R-57600, Permit R-7810,
A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 37 South, Range 6 West, WM Section 5 SE 1/4 SW 1/4 5.0 acres irrigation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit R-7810 and is subject to the terms and conditions of Contract 6-07-10-W0611 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.

Actual construction work shall begin on or before August 7, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
