PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68724 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Richard L. and Sandra M. Twigg, dba Twigg Farm, Route 2, Box 358, Cornelius, Oregon, 97113, phone 628-1596, for the use of the waters of an unnamed stream, a tributary of Tualatin River, and reservoir, constructed under * for the PURPOSE of irrigation of 50.8 acres,

that the PRIORITY OF THE RIGHT dates from May 12, 1986

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 285.0 gallons per minute

The POINT OF DIVERSION is to be LOCATED: 1000 feet North and 220 feet West from the Southeast corner of the SW 1/4 Section 36, being within the SE 1/4 SW 1/4 Section 36, Township 1 South, Range 3 West, WM, in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 1 South, Range 3 West, WM	Section 36 SW 1/4	NE 1/4	13.2 acres
	SE 1/4	NW 1/4	18.6 acres
	SE 1/4	SW 1/4	5.0 acres
	NW 1/4	SE 1/4	14.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage from reservoir constructed under Permit R-1932, and shall conform to such reasonable rotation system as may be ordered by the proper state officer provided further water shall not be appropriated during the period from July 31 through September 15 of each year except for stored water.

Actual construction work shall begin on or before August 28, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89.
