PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68426 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Wickiup Water District of Route 6, Box 1022, Astoria, Oregon, 97103, phone 458-6555, for the use of the waters of Fat Buck Creek and Little Fat Buck Creek, a tributaries of Bear Creek, being 0.35 cubic foot per second from Fat * for the PURPOSE of quasi-municipal,

that the PRIORITY OF THE RIGHT dates from July 8, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.55 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: Diversion #1 (Little Fat Buck Creek)- 1468.32 feet South and 2006.20 feet East; Diversion #2 (Fat Buck Creek)- 1529.62 feet South and 1923.44 feet East, both from the North quarter corner of Section 2, both being within the SE 1/4 NE 1/4 Section 2, Township 7 North, Range 8 West, WM, in the County of Clatsop.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* Buck Creek and 0.20 cfs from Little Fat Buck Creek,

Actual construction work shall begin on or before September 17, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89.
