PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68751 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

Theodore F. Seeber of 10668 Kaufman Road, Silverton, Oregon, This permit is issued to 97381, phone 873-3140, for the use of the waters of Beaver Creek, a tributary of Pudding River, and a Reservoir constructed under Application R-37260, Permit R-2709, for the PURPOSE of irrigation of 12.6 acres,

that the PRIORITY OF THE RIGHT dates from

Township 7 South, Range 1 West, WM

June 9, 1986 for 0.125 cubic foot per second June 18, 1986 for 0.035 cubic foot per second

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.16cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: Diversion #1- 1630 feet North and 720 feet East from the West quarter corner of Section 17; Diversion #2- 298 feet South and 730 feet East from the Southwest corner of Section 8; Diversion #3- 198 feet South and 410 feet East from the Southwest corner of Section 8, all being within the NW 1/4 NW 1/4 Section 17, Township 7 South, Range 1 West, WM, in the County of Marion. A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Section 17 NW1/4 NW1/4 10.6 acres SW1/4 NW1/4 2.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-2709, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before September 17, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
