## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68782 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Oregon State Parks Division, 525 Trade Street SE, Salem, Oregon, 97310, phone 378-5017, for the use of the waters of Rogue River,

for the PURPOSE of irrigation of 35.5 acres,

that the PRIORITY OF THE RIGHT dates from July 10, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.44 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: Diversion #1- 1850 feet North and 575 feet East from the Southwest corner of Section 25; Diversion #2- 1670 feet South and 1720 feet East from the East quarter of Section 27; Diversion #3- 1350 feet South and 260 feet East from the East quarter of Section 27, being within: Diversion #1- NW 1/4 SW 1/4 Section 25; Diversion #2- SE 1/4 SW 1/4 Section 26; Diversion #3- \*

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

\* SW 1/4 SW 1/4 Section 26, all of Township 36 South, Range 4 West, WM, in the County of Jackson.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to  $\frac{1}{80}$  of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before September 29, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89.
