PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68817 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Alice Pellham of 78655 Territorial Road, Loraine, Oregon, 97451, phone 942-8645, for the use of the waters of Siuslaw River,

for the PURPOSE of irrigation of 58.0 acres,

that the PRIORITY OF THE RIGHT dates from August 8, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.73 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: North 59 degrees 4 minutes East 1262.8 feet from the Southwest corner of Section 30, being within the SW 1/4 SW 1/4 Section 30, Township 20 South, Range 4 West, WM, in the County of Lane.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 20 South, Range 4 West, WM Section 30 NE1/4 SW1/4 4.5 acres NW1/4 SW1/4 11.5 acres SW1/4 SW1/4 6.7 acres SE1/4 SW1/4 0.5 acre Section 31 NE1/4 NW1/4 9.0 acres NW1/4 NW1/4 25.8 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before September 29, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
