PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68342 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Ochoco Irrigation District, 1001 North Deer Street, Prineville, Oregon, 97754, phone 447-6449, for the use of the waters of Ochoco Creek, a tributary of Crooked River and stored water allowed under Transfer 5631 from Ochoco* for the PURPOSE of Industrial, to include maintenance of log ponds, sprinkling log decks, dust abatement, powerhouse cooling, equipment washing, fire protection and other miscellaneous uses relative to saw mill operations, that the PRIORITY OF THE RIGHT dates from September 2, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 2.75 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: #1- Ochoco Reservoir: 500 feet North and 250 feet East from the West quarter corner Section 5, being within the SW 1/4 NW 1/4 Section 5, Township 15 South, Range 17 East; #2- Pine Products Corp.: 240 feet South and 330 feet East from the North quarter corner Section 5, being within the NW 1/4 NE 1/4 Section 5, Township 15 South, Range 16 East; #3- Ochoco Lumber Co.:**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * Reservoir constructed under Application R-3587, Permit R-528,
- ** 1100 feet North and 960 feet East from the West quarter corner of the Northwest quarter of Section 4, being within the SW 1/4 NW 1/4 Section 4, Township 15 South, Range 16 East; #4- Louisiana-Pacific Corp.: 500 feet North and 250 feet East from the West quarter corner of Section 5, within the SW 1/4 NW 1/4 Section 5, Township 15 South, Range 17 East, WM, all in the County of Crook.

#2- Pine Products Corp.:

Actual construction work shall begin on or before November 25, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
