PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68823 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Michael J. Stansbury of 1383 Sable Drive, Roseburg, Oregon, 97470, phone 679-7661, for the use of the waters of North Umpqua River, a tributary of Umpqua River, for the PURPOSE of Domestic for one family and irrigation of 2.42 acres,

that the PRIORITY OF THE RIGHT dates from August 12, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.035 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 40 feet North and 250 feet West from the Southeast corner of NW 1/4 NE 1/4 Section 21, being within the NW 1/4 NE 1/4 Section 21, Township 26 South, Range 5 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 26 South, Range 5 West, WM Section 21 NE1/4 NE1/4 0.20 acre NW 1/4 NE 1/4 2.22 acres and Domestic use for one family

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before December 22, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
