PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68935 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Mark Olson of 420 East 5th Street, McMinnville, Oregon, 97128, phone 472-6161, for the use of the waters of an unnamed stream and Mark Olson Reservoir, a tributary of Ash Swale, to be constructed under Application R-68934, * for the PURPOSE of irrigation of 57.95 acres,

that the PRIORITY OF THE RIGHT dates from October 1, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.72 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 1320 feet South and 2100 feet West from the Northeast corner of Section 9, being within the NW 1/4 NE 1/4 Section 9, Township 6 South, Range 4 West, WM, in the County of Polk.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit R-10812, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before $\frac{1987}{1980}$, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
