## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68043 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Oregon Department of Fish and Wildlife, 506 SW Mill Street, Portland, Oregon, 97207, phone 229-5701, for the use of the waters of Fern Ridge Reservoir, constructed under Application 29397, Permit R-1625, for the PURPOSE of irrigation of 487.8 acres, being use of 55.27 acre-feet for irrigation of 314.0 acres (Phases I and II) and use of 434.5 acre-feet for irrigation of 173.8 acres (Phase III), that the PRIORITY OF THE RIGHT dates from February 25, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 489.77 acre-feet stored water only.

The POINT OF DIVERSION is to be LOCATED: Phase I and II: Diversion 1- 3700 feet North and 3970 feet West from the Southeast corner of Section 35; Diversion 3- 2800 feet North and 1250 feet West from the Southeast corner of Section 34; Phase III: Diversion 4- 1150 feet South and 300 feet East from the Northwest corner of Section 35, all being within the Phase I and II: Diversion 1- SW 1/4 NW 1/4 \* A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

\* Section 35; Diversion 3- SE 1/4 NE 1/4 Section 34; Phase III: Diversion 4-NW 1/4 NE 1/4 Section 35, all being within Township 17 South, Range 5 West, WM, in the County of Lane.

Fern Ridge Dam is located within SE 1/4 of Section 4 and SW 1/4 of Section 3, Township 17 South, Range 5 West, W.M., in the County of Lane.

Actual construction work shall begin on or before January 30, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1988, and shall thereafter be prosecuted with the same of the sa
