## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68258 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Webster Briggs of Route 1, Box 312, Myrtle Creek, Oregon, 97457, phone 839-4698, for the use of the waters of South Umpqua River, a tributary of Umpqua River, for the PURPOSE of irrigation of 101.9 acres.

that the PRIORITY OF THE RIGHT dates from January 22, 1985,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.27 cubic feet per second.

The POINT OF DIVERSION is to be LOCATED: Diversion #1: 150 feet South and 1200 feet West from the Southwest corner of Section 23; Diversion #2: 330 feet North and 1030 feet East from the Southwest corner of Section 23; Diversion #3: 1030 feet North and 3100 feet East from the Southwest corner of Section 23, all being within the Diversion #1: NE 1/4 NE 1/4 Section 27; Diversion #2: SW 1/4 SW 1/4 Section 23; Diversion #3:\* A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

SW 1/4 SE 1/4 Section 23, WM, in the County of Douglas.

4.3 acres The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the

proper state officer.

ctual construction work shall begin on or before January 30, 1988 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89.
