PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68645 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to R. G. Rencken of Route 2, Box 193, Milton-Freewater, Oregon, 97862, phone 558-3736, for the use of the waters of East Branch of Mud Creek, a tributary of Walla Walla River, for the PURPOSE of supplemental irrigation of 25.7 acres,

that the PRIORITY OF THE RIGHT dates from January 9, 1986 for 0.12 cubic foot per second
June 2, 1986 for 0.20 cubic foot per second,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.32 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 1300 feet South and 4 feet West from the Northeast corner of Section 21, being within the NE 1/4 NE 1/4 Section 21, Township 6 North, Range 35 East, WM, in the County of Umatilla.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 6 North, Range 35 East, WM	Section 21 NE1/4 NE1/4	10.0 acres
	Section 22 NW1/4 NW1/4	15.7 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before January 30, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89.
