PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68672 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Harry Harms (General Manager) of Hastings Bulb Gowers, Inc., PO Box 2155, Harbor, Oregon, 97415, phone 469-3759, for the use of the waters of two reservoirs to be constructed under Application R-68671, Permit R-10813, being 8.72 * for the PURPOSE of supplemental irrigation of 118.5 acres,

that the PRIORITY OF THE RIGHT dates from

November 17, 1986.

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 12.7 acre-feet stored water only.

The POINT OF DIVERSION is to be LOCATED: Reservoir A- (Pump location) 690 feet west and 565 feet south of the Northeast corner of Section 22; Reservoir B- (Gravity feed to Reservoir A) 540 feet west and 515 feet south of the Northeast corner of Section 22 being within the NE 1/4 NE 1/4 Section 22, Township 41 South, Range 13 West, WM, in the County of Curry.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* acre-feet from Reservoir A and 3.95 acre-feet from Reservoir B,

Township 41 South, Range 13 West, WM Section 15 SW1/4 SE1/4 11.6 acres

SE1/4 SE1/4 11.4 acres

Section 22 NE1/4 NE1/4 42.8 acres

NW1/4 NE1/4 30.1 acres

NEl/4 NWl/4 8.1 acres

Section 23 NW1/4 NW1/4 14.5 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 2.5 acre-feet from storage from reservoirs to be constructed under Permit R-10813.

Actual construction work shall begin on or before January 30, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19, 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89.
