PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68777 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Fred J. Duerst of PO Box 33, Trail, Oregon, 97541, phone 878-2352, for the use of the waters of Rogue River,

for the PURPOSE of Irrigation of 1.0 acre,

that the PRIORITY OF THE RIGHT dates from July 8, 1986.

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.013 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 185 feet South and 10 feet East from the quarter corner between Section 2, Township 35 South and Section 35, Township 34 South both in Range 1 West, being within the NW 1/4 NE 1/4 Section 2, Township 35 South, Range 1 West, WM, in the County of Jackson.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 34 South, Range 1 West, WM Section 35 SE1/4 SW1/4 0.36 acre

SW 1/4 SE 1/4 0.02 acre

Township 35 South, Range 1 West, WM Section 2 NW 1/4 NE 1/4 0.24 acre

NE 1/4 NW 1/4 0.38 acre

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before February 26, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1988.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
