PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68786 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to John Inman c/o Myron Miles of PO Box 129, North Powder, Oregon 97867, phone 898-2140, for the use of the waters of Warm Springs Creek, a tributary of Powder River, for the PURPOSE of Irrigation of 23.0 acres and supplemental irrigation of 211.0 acres,

that the PRIORITY OF THE RIGHT dates from July 14, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 5.85 cubic feet per second.

The POINT OF DIVERSION is to be LOCATED: 1290 feet North and 1290 feet West from the Southeast corner of Section 6, being within the SE 1/4 SE 1/4 Section 6, Township 7 South, Range 39 East, WM, in the County of Baker.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before February 26, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
