PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68812 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Richard E. Pickett c/o Timberline River Ranch, 1715 NE 122nd, Portland, Oregon, 97220, phone 254-4738, for the use of the waters of Wickiup Creek, a tributary of Crooked River, for the PURPOSE of Irrigation of 40.8 acres,

that the PRIORITY OF THE RIGHT dates from August 5, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.02 cubic feet per second.

The POINT OF DIVERSION is to be LOCATED: 153 feet North and 1035 feet East from the common Corner of Section 14, Section 15, Section 22 and Section 23, being within the SW 1/4 SW 1/4 Section 14, Township 16 South, Range 18 East, WM, in the County of Crook.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 16 South, Range 18 East, WM	Section 22 NE1/4 NE1/4	17.4 acres
	Section 23 NW1/4 NW1/4	23.4 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before March 17, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
