PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68847 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to J. Frank Schmidt, III of PO Box 189, Boring, Oregon, 97009, phone 663-4128, for the use of the waters of an unnamed stream, a tributary of Doane Creek and Goodwin Reservoir to be constructed under Application R-68846, * for the PURPOSE of Supplemental irrigation of 114.1 acres and containerized nursery stock use on 12.5 acres, being 1.43 cubic feet per second for irrigation and 1.5 cfs for containerized nursery stock use, that the PRIORITY OF THE RIGHT dates from September 4, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.58 cubic feet per second.

The POINT OF DIVERSION is to be LOCATED: Reservoir: 150 feet North and 200 feet West from the Southwest corner of Section 27 being within the SE 1/4 SE 1/4 Section 28; Unnamed stream: 100 feet North and 230 feet East from the Southwest corner of Section 27 being within the SW 1/4 SW 1/4 Section 27, both in Township 1 South, Range 4 East, WM, in the County of Clackamas.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from Goodwin Reservoir to be constructed under Permit R-10821, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before March 31, 1988 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
