## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68830** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Donald A. and/or Ines E. Oyler of 632 Marlin Court, Redwood City, California, phone (415) 595-1945, for the use of the waters of Rogue River, a tributary of Pacific Ocean, for the PURPOSE of Domestic use for one family and irrigation of 10.42 acres, being 0.005 cubic foot per second for domestic and 0.125 cfs for irrigation,

that the PRIORITY OF THE RIGHT dates from August 20, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.13 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 800 feet South and 1750 feet West from the Northeast corner of SE 1/4 of Section 3, being within the NW 1/4 SE 1/4 Section 3, Township 34 South, Range 1 West, WM, in the County of Jackson.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 34 South, Range 1 West, WM	Section 3	NW1/4 SE1/4	6.7 acres
		SW1/4 SE1/4	Domestic use for one family and irrigation of 3.72 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before April 23, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
