PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68845 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to James A. and Ramona J. Bishop of 1008 North Court, Burns, Oregon, 97720, phone (Home) 573-2305; (Work) 573-6023, for the use of the waters of Sagehen Creek, a tributary of Wilson Creek, for the PURPOSE of Irrigation of 12.4 acres,

that the PRIORITY OF THE RIGHT dates from September 2, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.16 Cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: #1-200 feet North and 225 feet West from the West quarter of Section 2; #2-250 feet South and 10 feet West from East quarter corner of Section 3, being within the #1- SE 1/4 NE 1/4; #2- NE 1/4 SE 1/4 both of Section 3, Township 24 South, Range 29 East, WM, in the County of Harney.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 24 South, Range 29 East, WM Section 2 NW1/4 SW1/4 12.4 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before April 23, 1988 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
