PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69012 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to James A. Clendenin and Thomas H. Orlando, 347 Indian Bend Road, Umpqua, Oregon, 97486, phone 459-5413, for the use of the waters of Umpqua River, a tributary of Pacific Ocean, for the PURPOSE of Irrigation of 40.0 acres,

that the PRIORITY OF THE RIGHT dates from February 11, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.5 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 690 feet North and 1220 feet East from the West quarter corner of Section 29, being within the SW 1/4 NW 1/4 Section 29, Township 24 South, Range 7 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 24 South, Range 7 West, WM	Section 29	SW1/4 NW1/4	11.5 acres
		SE1/4 NW1/4	3.0 acres
		NE1/4 SW1/4	6.2 acres
		NW1/4 SW1/4	19.3 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before April 23, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89.

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 . Extended to October 1, 1991
