PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68759 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Rick Lynn, Sr. of 722 Hammel Road, Eagle Point, Oregon, 97524, phone 826-3620, for the use of a waste water from a drainage ditch collecting surface run-off and waste waters from the Eagle Point Irrigation District, for the PURPOSE of Irrigation of 18.7 acres,

that the PRIORITY OF THE RIGHT dates from June 17, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.23 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: POD #1- 50 feet South and 1320 feet East from the North quarter corner of Section 9; POD #2- 880 feet South and 1320 feet East of the North quarter coner of Section 9, both being within the NW 1/4 NE 1/4 Section 9, Township 35 South, Range 1 West, WM, in the County of Jackson.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 35 South, Range 1 West, WM Section 9 NW1/4 NE1/4 18.7 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall also be limited to the water available at the proposed point of diversion, and shall not carry with it the right to compel the continuance of the waste water, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before May 27, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1989.

Complete application of the water to the proposed use shall be made on or before October 1, 19 $\,$ 90 $\,$.
