PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68948** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Russell H. Bingaman** of PO Box 129, Imbler, Oregon, 97841, phone **963-8196**, for the use of the waters of **Grande Ronde River**, a tributary of Snake River, for the PURPOSE of **Irrigation of 105.0 acres**,

that the PRIORITY OF THE RIGHT dates from **October 23, 1986**,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **2.5 cubic feet per second**.

The POINT OF DIVERSION is to be LOCATED: **2130 feet South and 1190 feet West from the Northeast corner of Section 33, being within the SE 1/4 NE 1/4 Section 33, Township 1 South, Range 39 East, WM, in the County of Union.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 1 South, Range 39 East, WM	Section 27 SW1/4 SE1/4	35.0 acres
	Section 34 NW1/4 NE1/4	32.0 acres
	SW1/4 NE1/4	38.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **May 27, 1988**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 19 89**.

Complete application of the water to the proposed use shall be made on or before **October 1, 19 90**.
