PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69047 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to James Hamilton Cheek of 3491 Del Rio Road, Roseburg, Oregon, 97470, phone 673-6730, for the use of the waters of North Umpqua River, a tributary of Umpqua River, for the PURPOSE of Irrigation of 2.93 acres,

that the PRIORITY OF THE RIGHT dates from April 3, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.04 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 240 feet South and 510 feet East from the Northwest corner of NE 1/4 NE 1/4, being within the NE 1/4 NE 1/4 Section 27, Township 26 South, Range 6 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 26 South, Range 6 West, WM	Section 27	NE1/4 NE1/4	1.4 acres
		NW1/4 NE1/4	1.53 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before June 30, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89.

Complete application of the water to the proposed use shall be made on or before October 1, 19 90.
