PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68879 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Frank Spriet of Route 1, Box 75, Baker, Oregon 97814, phone 523-3027, for the use of the waters of Mill Creek, an unnamed spring and an unnamed stream, being 33.0 gallons per minute from Mill Creek, 5.0 gallons per minute* for the PURPOSE of Irrigation of 4.0 acres,

that the PRIORITY OF THE RIGHT dates from September 22, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 45.0 gallons per minute.

The POINT OF DIVERSION is to be LOCATED: Mill Creek - 2580 feet South and 1320 feet West from the Northeast corner of Section 1; Unnamed Spring - 2430 feet South and 1010 feet West from the Northeast corner of Section 1; Unnamed stream - 2390 feet South and 1430 feet West from the Northeast corner of **

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * from the spring, and 7.0 gallons per minute from the stream,
- ** Section 1, being within the Mill Creek SW 1/4 NE 1/4; Unnamed Spring Lot 3 (SE 1/4 NE 1/4); Unnamed stream SW 1/4 NE 1/4, all in Section 1, Township 9 South, Range 38 East, WM, in the County of Baker.

Township 9 South, Range 38 East, WM Section 1 SE1/4 NE1/4 Lot 3 4.0 acres Irrigation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before July 24, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19, 89.

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
