PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68610 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to City of Salem of 555 Liberty Street SE, Salem, Oregon 97301, phone 588-6016, for the use of the waters of North Santiam River, a tributary of Willamette River, for the PURPOSE of Aesthetics,

that the PRIORITY OF THE RIGHT dates from November 6, 1985,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 70.0 cubic feet per second.

The POINT OF DIVERSION is to be LOCATED: 370 feet East and 565 feet South from the Northwest corner of Section 11, being within the SE 1/4 SW 1/4, Section 11, Township 9 South, Range 1 West, WM, in the County of Marion.

This permit is issued subject to the following conditions: (1) The City of Salem shall provide and maintain to the satisfaction of the Oregon Department of Fish and Wildlife, upstream and downstream fish passage facilities in any watercourse under the City's operational control affected by this diversion. (2) The City will work with the Oregon Department of Fish and Wildlife to determine and implement, in so far as is practical, the most beneficial distribution of flows within the Mill Creek system for optimum reproduction and growth of fish.

Actual construction work shall begin on or before August 18, 1988 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
