PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **69028** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Lamont L. and Doreen R. Rungay of 17951 S. Springwater Road, Oregon City, Oregon 97045, phone 631-2318, for the use of the waters of an unnamed stream and two reservoirs to be constructed under Application R-69027, Permit R-10831, for the PURPOSE of Irrigation of 10.0 acres and recreation, being 56.0 gallons per minute for irrigation and 5.0 gpm for maintaining the two reservoirs for recreation,

that the PRIORITY OF THE RIGHT dates from **March 13, 1987,**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **61.0** gallons per minute.

The POINT OF DIVERSION is to be LOCATED: Reservoir #1 - 200 feet South and 850 feet East from the Northeast corner of DLC 37; Reservoir #2 - 450 feet South and 1075 feet West from the Northeast corner of DLC 37, both being within the NE 1/4 NW 1/4, Section 3, Township 3 South, Range 3 East, WM, in the County of Clackamas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **August 18, 1988**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **89** *extended to 4-10-90*

Complete application of the water to the proposed use shall be made on or before October 1, 19 **90**.
