PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 67962 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to LeRoy McBride of Route 1, Box 367, Ontario, Oregon 97915, phone 889-6790, for the use of the waters of Malheur River, a tributary of Snake River,

for the PURPOSE of Irrigation of 72.0 acres,

that the PRIORITY OF THE RIGHT dates from February 28, 1985,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.8 cubic feet per second.

The POINT OF DIVERSION is to be LOCATED: North 85 degrees, 55 minutes East a distance of 1995 feet from the West quarter corner of Section 16, being within the SE 1/4 NW 1/4, Section 16, Township 18 South, Range 46 East, WM, in the County of Malheur.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before August 18, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89.

Complete application of the water to the proposed use shall be made on or before October 1, 19 90.
