## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69001 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to John N. and Dixie L. Farnsworth of 4720 Riordan Hill Road, Tony W. and Maxine L. Freitas of 4715 Riordan Hill Road and David W. and Elizabeth Thomas of 4725 Riordan Hill Road, all of Hood River, 97031, phone\* for the PURPOSE of Domestic use for three families including the irrigation of not to exceed one-half acre of lawn or noncommercial garden for each family,

that the PRIORITY OF THE RIGHT dates from June 19, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.02 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 2383 feet South and 341 feet East from the Northwest corner of Section 4, being within the SW1/4 NW1/4 of Section 4, Township 2 North, Range 10 East, W.M., in the County of Hood River.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 2 North, Range 10 East, W.M., Section 4 SW1/4 NW1/4 Domestic use for

three families including the irrigation of not to exceed one-half acre lawn or noncommercial garden for each

\* (Farnsworth) 386-1154, (Freitas) 386-6370 and (Thomas) 386-4731, for use of the waters of a spring and runoff, a tributary of Phelps Creek,

The use of water under this right is subject to the terms and conditions of a Water Use Agreement recorded in Miscellaneous Records of the Water Resources Director, Volume 7, Pages 1811, 1812, 1813 and 1814.

Actual construction work shall begin on or before November 24, 1988 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89.

Complete application of the water to the proposed use shall be made on or before October 1, 19 90.
