## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69015 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Tigard Christian Church by Henri Van Tricht, Chairman of the Board, of 13405 S.W. Hall Boulevard, Tigard, Oregon 97223, phone 639-5713, for the use of the waters of Fanno Creek, a tributary of the Tualatin River, for the PURPOSE of irrigation of 3.64 acres

that the PRIORITY OF THE RIGHT dates from February 17, 1987 for 10.0 gpm and September 22, 1987 for 9.5 gpm,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed

19.5 gallons

per minute.

The POINT OF DIVERSION is to be LOCATED:

860 feet South and 830 feet West from the East Guarter Corner of Section 2, being within the NE1/4 SE1/4 of Section 2, Township 2 South, Range 1 West, W.M., in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 2 South, Range 1 West, W.M., Section 2

NE1/4 SE1/4

3.64 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further water shall not be appropriated from direct flow during the period from July 31 through September 30 of each year, and shall conform to such reasonable rotation as may be ordered by the proper state officer.

Actual construction work shall begin on or before November 24, 1988 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89.

Complete application of the water to the proposed use shall be made on or before October 1, 19  $_{90}$  .
