PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69090 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Jack E. Downs of 12087 Highway 238, Jacksonville, Oregon 97530, phone 846-7429, for the use of the waters of the Applegate River and Applegate Lake Reservoir constructed under Permit R-7810, for the PURPOSE of irrigation of 1.0 acre

that the PRIORITY OF THE RIGHT dates from May 8, 1987

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.025 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 1300 feet South and 610 feet East from the North Quarter Corner of Section 25, being within the NW1/4 NE1/4 of Section 25, Township 38 South, Range 4 West, W.M.; Applegate Reservoir Dam is located within the S1/2 SE1/4 of Section 25, Township 40 South, Range 4 West, W.M., all in*

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 38 South, Range 4 West, W.M., Section 25 NW1/4 NE1/4 1.0 acre

* the County of Jackson.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from Applegate Lake Reservoir constructed under Permit R-7810, and is subject to the terms and conditions of Contract 7-07-10-W0682 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director, and shall conform to such reasonable rotation as may be ordered by the proper state officer.

Actual construction work shall begin on or before November 24, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
