PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **69335** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Pat Wolford** of 12570 Mt. Hamilton Road, San Jose, California, 95127, phone (415) 968-4630 work or (408) 945-2990 home, for the use of the waters of the Rogue River and Lost Creek Reservoir, constructed under Application 56223, * for the PURPOSE of irrigation of 2.5 acres,

that the PRIORITY OF THE RIGHT dates from **September 30, 1987,**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.03** cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: River - 1780 feet North and 1500 feet West from the Southeast Corner of Section 5, being within the NW 1/4 SE 1/4 of Section 5, Township 35 South, Range 1 West; Lost Creek Reservoir (dam) - SW 1/4 NW 1/4 and W 1/2 SW 1/4 of Section 26, Township 33 South, Range 1 East, WM, both in the County of Jackson.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* Permit R-8142, tributaries of the Pacific Ocean,

Township 35 South, Range 1 West, WM Section 5 NW 1/4 SE 1/4 2.5 acres Irrigation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of Contract 8-07-10-W0704 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which shall be on file in the records of the Water Resources Director, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **December 30, 1988**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **89**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **90**.
