## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69225 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Richard K. and Lillian J. Lundsten of 196 Hoot 'n Holler Lane, Roseburg, Oregon 97470, phone 672-3855, for the use of the waters of the South Fork Deer Creek, a tributary of Deer Creek, for the PURPOSE of Irrigation of 2.8 acres and livestock water,

that the PRIORITY OF THE RIGHT dates from August 7, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.04 cubic foot per second, being 0.035 cfs for irrigation and 0.005 for livestock.

The POINT OF DIVERSION is to be LOCATED: 560 feet South and 2310 feet West from the Northeast corner of Section 1, being within the NW1/4 NE1/4 of Section 1, Township 28 South, Range 5 West, W.M., in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 28 South, Range 5 West, W.M., Section 1 NW1/4 NE1/4 2.8 acres and livestock

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall be further limited during the period from July 15 through September 30 of each year to livestock water and irrigation of a noncommercial garden not to exceed one-half acre in area, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before December 31, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89

Complete application of the water to the proposed use shall be made on or before October 1, 19 90.
