PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69398 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to State of Oregon, Department of Forestry, of Box 2424 Wells Road, Elkton, Oregon 97450, phone 584-2214, for the use of the waters of the Umpqua River and Galesville Reservoir constructed under Application R-61641, * for the PURPOSE of commercial nursery uses, to include irrigation during the period October 1 through March 31 of each year when water can be put to beneficial use for immediate crop growth or to raise the soil moisture content to be** that the PRIORITY OF THE RIGHT dates from October 7, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 6.0 cubic feet per second.

The POINT OF DIVERSION is to be LOCATED: #1: 324.45 feet North and 2164.25 feet West; #2: 251.99 feet South and 476.49 feet West, both from the corner common to Sections 1, 2, 11 and 12; #3: 11.9 feet North and 37.5 feet West from the Meander Corner between Sections 11 and 12, all in Township 23 South, Range 8 West, W.M. Galesville Reservoir Dam is located within the SE1/4 NE1/4 of***

This permit is issued subject to the terms and conditions of an agreement between the State of Oregon, Department of Forestry and Douglas County, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.

Actual construction work shall begin on or before **December 31, 1988**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **89**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **90**.
