## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69126 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Gregg Adams (White Oak Mobile Home Park) of P.O. Box 1084 Medford, Oregon 97501, phone 772-4069, for the use of the waters of the Rogue River and Lost Creek Reservoir constructed under Permit R-8142, for the PURPOSE of supplemental irrigation of 8.0 acres and domestic use for 70 families (mobil home park),

that the PRIORITY OF THE RIGHT dates from June 8, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.12 cubic foot per second, being 0.09 cfs from the Rogue River and Lost Creek Reservoir for supplemental irrigation and 0.03 cfs from the Rogue River for a primary\*

The POINT OF DIVERSION is to be LOCATED: 1260 feet South and 2510 feet East from the Northwest corner of Section 10, being within the NE1/4 NW1/4 of Section 10, Township 34 South, Range 1 West, W.M. Lost Creek Reservoir dam is located in the SW1/4 NW1/4 and W1/2 SW1/4 of Section 26, Township 33 South, Range 1 East, W.M., all in the County of Jackson

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 34 South, Range 1 West, W.M., Section 3

Supplemental irrigation SW1/4 SW1/4 8.0 acres Group Domestic Use SW1/4 SW1/4

\* supply for 26 families and a supplemental supply for 44 families.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from Lost Creek Reservoir constructed under Permit R-8142, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and is subject to the terms and conditions of Contract 8-07-10-W0700 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before January 21, 1989, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89.

Complete application of the water to the proposed use shall be made on or before October 1, 19 90.
