PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **69222** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Roger Nicholson Cattle Company of Box 458, Fort Klamath, Oregon 97626**, for the use of the waters of Wood River, a tributary of Agency Lake, for the PURPOSE of **supplemental irrigation of 160.0 acres**,

that the PRIORITY OF THE RIGHT dates from **November 3, 1987**,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **3.2 cubic feet per second**.

The POINT OF DIVERSION is to be LOCATED: **South 20 degrees 33.5 minutes West a distance of 2729.6 feet from the North Quarter Corner of Section 10, being within the SE1/4 NW1/4 of Section 10, Township 33 South, Range 7 1/2 East, W.M., in the County of Klamath.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 33 South, Range 7 1/2 East, W.M., Section 20	SW1/4 SW1/4	40.0 acres
	SE1/4 SW1/4	40.0 acres
Section 29	NE1/4 NW1/4	40.0 acres
	NW1/4 NW1/4	40.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/50 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to making up any deficiency in the available supply of water from Anna Creek allowed under existing rights for the same land, and to bring the quantity of water to the full duty allowed from Wood River, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **February 28, 1989** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **89**

Complete application of the water to the proposed use shall be made on or before October 1, 19 **90**
