PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69286 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to John Van Beek of 26405 McFarland Road, Monroe, Oregon 97456, phone 424-3752, for the use of the waters of Muddy Creek and effluent from dairy complex and animal waste holding reservoir to be constructed under Application R-69285, * for the PURPOSE of washing in dairy complex, irrigation of 4.0 acres and supplemental irrigation of 141.0 acres, being 0.045 cfs from Muddy Creek for washing in the dairy complex and 1.8 cfs from effluent from the dairy complex and animal waste ** that the PRIORITY OF THE RIGHT dates from September 10, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.845 cubic feet per second.

The POINT OF DIVERSION is to be LOCATED: Muddy Creek - 1700 feet South and 1750 feet East from the Northwest Corner, Section 17, being within the SE 1/4 NW 1/4 of Section 17; Collection Tank - 2100 feet South and 580 feet West from the Northeast Corner of Section 18; Holding Pond - 2000 feet South and 450 feet West from the Northeast Corner of Section 18, both being within the SE 1/4 NE 1/4 of ***

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- ** holding reservoir for irrigation and supplemental irrigation,

Section 18 SE 1/4 NE 1/4 DAIRY COMPLEX

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre, from direct flow and storage from reservoir constructed under Permit R-9974, provided further that although declared hereinto be for supplemental irrigation, the right may, in the interest of proper operation of the manure storage lagoon, be exercised at times when water is available at the primary source provided, that the total quantity diverted from all sources of supply shall not exceed the limitation allowed herein.

Actual construction work shall begin on or before February 28, 1989 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
