PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69325 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Lincoln Horizons, Inc. of 11875 Orrs Corner Road, Dallas, Oregon, 97338, phone 623-5089, for the use of the waters of Rickreall Creek and unnamed reservoir to be constructed under Application R-69324, Permit R-10894 * for the PURPOSE of recreation (esthetics) and irrigation, being 0.11 cubic foot per second from Rickreall Creek for maintaining the unnamed reservoir for recreation, 0.23 cfs from Rickreall Creek for primary irrigation of 18.2 acres and use of 10.0 ** that the PRIORITY OF THE RIGHT dates from September 25, 1987, for use of 0.23 cfs from Rickreall Creek and stored water, December 2, 1987, for use of 0.11 cfs from Rickreall Creek for recreation,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.33 cubic foot per second,

The POINT OF DIVERSION is to be LOCATED: Reservoir - 50 feet South and 420 feet East; Rickreall Creek - 390 feet South and 420 feet East both from the Northeast Corner of DLC 66, being within the NW 1/4 SW 1/4 of Section 35, Township 7 South, Range 5 West, WM, in the County of Polk.

- * provided that the right allowed herein shall not provide for the use of water from Rickreall Creek during the period July 31 through September 30 of each year,
 ** acre-feet stored water annually for supplemental irrigation of said 18.2 acres and supplemental irrigation of 19.7 acres,

Actual construction work shall begin on or before February 28, 1989, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1989.

Complete application of the water to the proposed use shall be made on or before October 1, 1990.
