PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69533 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to John W. Mitsch of 1116 N.W. Knights Bridge Road, Canby, Oregon 97013, phone 266-5531, for the use of the waters of the Molalla River, a tributary of the Willamette River, for the PURPOSE of operation of a heat pump and irrigation of 0.6 acre,

that the PRIORITY OF THE RIGHT dates from February 8, 1988,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.04 cubic foot per second, being 0.04 cfs for operation of heat pump and 0.01 cfs for irrigation.

The POINT OF DIVERSION is to be LOCATED: 302 feet North and 3275 feet East from the West quarter-corner of Section 32, being within the SW1/4 NE1/4 of Section 32, Township 3 South, Range 1 East, W.M., in the County of Clackamas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 3 South, Range 1 East, W.M., Section 32 SW1/4 NE1/4 Operation of heat pump and 0.6 acres irrigation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before March 28, 1989, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
