PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69430 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Charles W. Collins of #3 Mt. View, Roseburg, Oregon 97470, phone 672-2180, for the use of the waters of Umpqua River, a tributary of Pacific Ocean,

for the PURPOSE of irrigation of 198.0 acres,

that the PRIORITY OF THE RIGHT dates from October 28, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 2.48 cubic feet per second

The POINT OF DIVERSION is to be LOCATED: #1-2200 feet South and 950 feet East; #2-700 feet North and 1850 feet East; and #3-2150 feet North and 1250 feet East all from the West Quarter Corner of Section 18, being within the #1-SW 1/4 SW 1/4; #2-SE 1/4 NW 1/4; and NW 1/4 NW 1/4, all of Section 18, Township 26 South, Range 6 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before March 29, 1989, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1989.

Complete application of the water to the proposed use shall be made on or before October 1, 1990 .
