PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68188 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to The Pocahontas Farmers' Ditch Company of PO Box 843, Baker, Oregon 97814, phone 523-3666, for the use of the waters of Salmon Creek, Marble Creek, Hibbard Gulch and Mill Creek,

for the PURPOSE of irrigation of 6.72 acres and supplemental irrigation of 466.2 acres,

that the PRIORITY OF THE RIGHT dates from February 11, 1985,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed ll.82 cubic feet per second, being 0.17 cubic foot per second from Salmon Creek when available with any deficiency to be made up by appropriation from Marble Creek, Hibbard Gulch and * The POINT OF DIVERSION is to be LOCATED: Mill Creek - 200 feet South and 1900 feet West from the E 1/4 Corner of Section 1, Township 9 South, Range 38 East, WM; Salmon Creek - 700 feet North and 100 feet East from the Southwest Corner of Section 4; Hibbard Gulch - 200 feet North and 1800 feet East from the Southwest Corner of Section 4; Marble Creek - 600 feet North and 700 feet East from the Southwest Corner of ** A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * Mill Creek in that order for irrigation of 6.72 acres; 1.48 cfs from Marble Creek, with any deficiency to be made up by appropriation from Hibbard Gulch and Mill Creek in that order for supplemental irrigation of 59.1 acres; 1.61 cfs from Marble Creek with any deficiency to be made up by appropriation from Mill Creek for supplemental irrigation of 64.5 acres; 8.56 cfs from Salmon Creek with any deficiency to be made up by appropriation from Hibbard Gulch for supplemental irrigation of 342.6 acres.
- ** Section 6, all being within Township 9 South, Range 39 East, WM, in the County of Baker.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before May 25, 1989, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19, 90.

Complete application of the water to the proposed use shall be made on or before October 1, 19 91.
