PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69513 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to City of Carlton, City Hall, 191 E. Main, Carlton, Oregon 97111, phone 852-7575, for the use of the waters of Panther Creek, a tributary of North Yamhill River, and 9.0 acre-feet from City of Carlton's Panther Creek Reservoir * for the PURPOSE of municipal purposes,

that the PRIORITY OF THE RIGHT dates from November 30, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.07 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 2330 feet South and 40 feet East from the Center Corner of Section 18, being within the SW 1/4 SE 1/4 of Section 18, Township 3 South, Range 5 West, WM, in the County of Yamhill.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:
